This includes any payment or financial benefit within the meaning of the Trade Union and Labour Relations Act 1992.	
3: contracts	
State any contract which is made between the relevant person (or body in which the relevant person has a beneficial interest) and the relevant authority under which goods and services are to be provided or works are to be executed; and which have not been fully discharged.	

4: land	
State any beneficial interest in land which is within the area of the relevant authority.	
5: licences	
State any licence you hold (alone or jointly with others) to occupy land in the area of the relevant local authority for a month or longer.	
6: corporate tenancies	
State any tenancy where – to your knowledge – the landlord is the relevant authority and the tenant is the body in which the relevant person has the beneficial interest.	
7: securities	
State any beneficial interest in securities of a body where that body - to your knowledge - has a place of business or land in the area of the relevant local authority and either: the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body, or if the share capital of that body is of more than one class, the total nominal value of the shares of any class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class
